How to enter

- This promotion commences on **Thursday 1 June 2023** and closes at **5pm on Thursday 31 August 2023 (Promotion Period)**.
- The offer is available to new residential Grey Power Electricity customers who sign up their electricity to Grey Power Electricity, between 1 June 2023 and 31 August 2023. Current Grey Power Electricity customers will automatically be entered in the draw to win.
- Employees of Grey Power Electricity, their immediate families, and employees of any agencies connected in any way with the Prize Draw or helping to set up the prize draw are ineligible to enter.
- By signing up your electricity with Grey Power Electricity and therefore entering the Prize Draw, you acknowledge that you have read and understood and agree to be bound by these Terms and Conditions.
- Grey Power Electricity reserves the right, at any time, to verify the validity of entries and to disqualify any entrant who does not comply with these Terms and Conditions.

Prize

- There will be one (1) prize winner (**Winner**) only.
- The Winner will receive a prize being up to \$1,200 (including GST) worth of electricity credits to the Winner's Grey Power Electricity account, on the terms and conditions set out below (**Prize**).
- The Winner will receive the Prize by being granted \$200 per month credit for electricity usage for six months, up to a total value of the electricity credits of no more than \$1,200. In all cases, the \$1,200 credit may only be used in relation to electricity for a residential property and must be used within six months of the Prize being notified to the Winner. The Prize is not transferable, refundable nor redeemable for cash, except that Grey Power

Electricity reserves the right to pay out the remaining credit on the Prize to the Winner at any time.

- The Prize Draw will be conducted by random draw on or about 4 September 2023 and Grey Power Electricity will endeavour to notify the Winner using the contact details on their account as soon as practicable following the Prize Draw.
